ORDER

This order may be read with reference to the previous order dated 22.08.2019.

2. The appellant states that he is satisfied with the information provided. He further states that he has not been provided the information within the time as prescribed under the RTI Act 2005. He has, therefore, suffered mental harassment and financial loss in attending the hearings in the Commission. For this the appellant demands that the Respondent be penalized and he be compensated for the detriment suffered.

3. After hearing both the parties, it is observed that there are glaring systemic deficiencies in the office of District Controller Food and Civil Supplies, Consumer Affairs, Sarabha Nagar, Distt. Ludhiana. Appropriate mechanism has not been provided to keep the record properly by the public authority due to which the information / request under RTI Act, 2005 are not being served properly. However, the respondent is warned to be careful in future while dealing with the RTI applications.
