1. The RTI application is dated **19.9.2019** vide which the appellant has sought information **regarding appointment of SAS qualified employees on the post of SO from 1990 to 1995,** as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **4.11.2019** and second appeal was filed in the Commission on **15.1.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **30.7.2020**.

2. Both the parties are present through Video Conference Facility in the DC office, at Mohali. As directed by this Commission at the last hearing on 30.7.2020, the respondent PIO, represented by Vishal Khullar, Senior Assistant and Jasbir Thakur, Section Officer, have submitted a detailed pointwise reply to the RTI application in the form of duly Notarized Affidavit. The appellant however, raised some objections to the language of the affidavit. In light of this the affidavit, a copy of which is available on file, was examined closely and pointwise, following which, it is this Commission's view that this RTI request has been adequately addressed.
