5. Despite adequate notice for the hearing, the appellant is absent for today's hearing without any intimation to the Commission. It is presumed that he is satisfied with the information/reply provided by the PIO, as such he does not seem to be interested in pursuing the case further.

6. From the perusal of reply filed by the respondent, the Bench observes that information has been denied to the appellant under Section 8(1) (J) of the RTI Act, 2005. I agree with the contention of the respondent as given above. As such, no further action is required in this case. Hence, the instant Appeal case is **disposed off and closed**.
