## **ORDER:**

The date of RTI Application is 19.06.2018 and the Date of First Appeal is 17.08.2018. The 2<sup>nd</sup> Appeal in the Commission was received on 08.10.2018.

Sh.Ashwani Sharma, Advocate appeared on behalf of the Appellant Sh.Kans Raj Saini and produced his Power of Attorney. He states that the Appellant has been provided the information regarding Jamabandi vide letter No.RTI/1179 OK dated 02.08.2018.

Shri Ashwani Sharma, Advocate, however, further states that no information prior to 1961-62 has been supplied and the information regarding 1961-62 is in Urdu. Upon this, the representative of PIO Sh. Dev Raj hands over a copy of the letter No.RTI/1227/ OK dated 28.12.2018 from PIO-cum-Tehsildar, Pathankot to the Appellant as well as to the Court during the court proceedings. With this letter, a copy of letter dated 02.08.2018 alongwith the report of Naib Tehsildar, Narot Jaimal Singh is enclosed. As per this report, the information regarding Jamabandi for the year 2012-13, 1967-68 and 1961-62 has been given. It is further stated in the report that no record relating Jamabandi prior to the year 1961-62 is available. Copy of the letter with information relating to Jamabandi for the year 1961-62 which in Urdu is taken on record.

**Appeal Case No.3432/2018**

Sh.Dev Raj also states before the Court that no Jamabandi record prior to 1953 is available in their office. He further states that the information for Jamabandi for the year 1961-62 is available only in Urdu language, whereas the information from 1967-68 onwards till 2009-2010, from which year computerization of the revenue record was started as per Sh.Dev Raj, is in Punjabi Language.

After discussing the case with Sh. Ashwani Sharma, Advocate and Sh.Dev Raj & Sh.Harsh Kumar who came present on behalf of PIO/Respondent, it is decided that the Appellant will visit the Patwari Sh.Harsh Kumar by making contact with him on phone, **to inspect the record on 07.01.2019** and to get the requisite information. Sh.Harsh Kumar, Patwari will ensure that requisite information as required by the appellant as per his RTI Application, is provided to him.

Since as per the registered postal receipt produced by the representative of PIO/Respondent and the e-mail dated 02.01.2019 sent by the Complainant himself to have received the information to his satisfaction, the information stands supplied to the Complainant. **As such, the instant complaint case is disposed of and the case is closed.**
