- 2. The representative of the respondents states that he has brought the complete original record pertaining to the RTI application of the appellant.
- 3. The appellant inspected the original record and got the copies of documents after identification. After getting the sought information, the appellant further requested for the compensation due to delay in providing the information as his RTI application was filed on 9.12.2019.
- 4. The perusal of the file shows that in this case, application for information was filed on 9.12.2019 but after lapse of more than one year the complete information has been given to the appellant. It is, thus apparent from the response of the respondent-PIO that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act.
- 5. I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 5000/- (Rupees Five thousands only) by way of compensation to the Appellant. This amount shall be payable from the State Exchequer by the office of the Block Development and Panchayats Officer, Guru Harsahai, Ferozepur before the next date of hearing.
