**ORDER**

1. This order may be read with reference to the order dated 03.02.2020 passed by this Bench on the last date of hearing.

2. Shri Sukhchain Singh, Appellant comes present and states that the requisite information has not been provided to him.

3. On the previous hearing, PIO-cum-EO Municipal Council, Fatehgarh Churian was directed to make available the official record for perusal of the appellant and also to make available photocopies of the documents identified by the appellant.

4. Today, neither the PIO has come present before the Bench nor he has sent any intimation to this effect.

5. On the asking of the Bench, the appellant states that as per orders of Commission, he went to the office of Executive Officer, Municipal Council, Fatehgarh Churian to peruse official record of Municipal Council and to get photocopies of the documents identified after perusal. For this purpose, he wanted to hand over a letter dated 18.02.2020 to the PIO to allow him to peruse the records so as to get photocopies of the documents identified, but the office of PIO flatly refused to receive any letter from him.

6. The Bench observes that in spite of directions of Bench, the PIO did not allow the appellant to inspect the records and even refused to receive copy of the letter from the appellant. This amounts to willful and intentional disobedience of the orders of Commission. This type of irresponsible behavior on the part of a public servant cannot be tolerated and accepted.

7. The PIO- cum-Executive Officer, Municipal Council, Fatehgarh Churian, District Gurdaspur is issued show cause notice to explain as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for disobedience of the orders of Commission. He is directed to also file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

8. In addition to the written reply, PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceeding against him ex-parte. PIO is also directed to comply with the direction of Bench given on the previous date of hearing.

9. The matter is adjourned. To come up for hearing on **31.03.2020 at 11.30 AM**. Copies of the order be sent to the parties.

2. Shri Sukhwinder Singh, Appellant has neither come present nor any information in this regard has been received from him.

4. Even after a lapse of 48 hours, no documents have been received and Smt. Sonia Bala is also not responding to repeated calls of the PS and Reader. The whole episode paints a very dismal picture of the way in which RTI cases are being handled in the Education Department.

5. The Bench observes that neither the PIO had come present on the previous hearing nor has come himself today to attend the hearing. His representative showed up very late without any case related document. His absence is viewed adversely. The PIO O/o Secretary, School Education, Punjab is issued show cause notice to explain his absence and also to show as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for disobedience of the orders of Commission. He is directed to also file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

6. In addition to the written reply, PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceeding against him ex-parte. PIO is also directed to provide the requisite information to the appellant before next date of hearing.

7. The matter is adjourned. To come up for hearing on **24.04.2020 at 11.30 AM.** Copies of the order be sent to the parties.

4. The appeal cases were deliberated at length. It emerges that the PIO O/o Director, Local Govt. has not understood the RTI Application of the appellant. The main concern of the appellant in this RTI application is to seek the information regarding the action taken on his complaint made to the Principal Secretary, Local Govt., Punjab. This is the main issue of the RTI application and the appeal case.

5. The appellant highlights that he had made a complaint to the authorities on many cases of fire incidents which have taken place in residential areas of Ludhiana due to factories and commercial activities happening illegally. He wants information on the action taken by the Govt. on his complaint in this regard.

6. During discussion, it emerges that Ms. Monika, Municipal Town Planner, Municipal Corporation, Ludhiana is the officer responsible and she is, thus, impeladed as the respondent.

7. In view of the above, the case is adjourned. To come up for hearing on 24.03.2020 at 11.30 AM. Copies of the order be sent to the parties concerned.

The PIO also delivers a copy of the same to the Bench which is taken on record. In addition to this, a letter dated 02.03.2020 of the B.P.E.O. Majri is also produced informing that the appellant had joined Govt. Primary School, Manak Sharief, Block Majri on 12.03.2019 and since then, no case for grant of permission to appear in the examination has been received by them.
4. On the asking of the Bench, the appellant expresses his satisfaction over the information supplied to him.
