ORDER

4. **Mr. Pardeep Mattu, FAA-cum- Joint Director Drugs is directed to take suitable disciplinary action against the delinquent PIO Smt. Jasbir Kaur as contemplated under Section 20 (2) RTI Act 2005. A compliance report in this regard be sent to the**

Commission accordingly. He is also directed to ensure that the amount of penalty i.e. Rs. 6000/- is deducted from the salary of Smt. Jasbir Kaur, Supdt.-cum- PIO and deposited in the Treasury under the relevant head.

5. After hearing both the parties and the perusal of the record reveals that the department had not implemented the Section 4 of the RTI Act 2005. According to Section 4, it is mandatory for every public authority shall maintain all its records duly catalogued and indexed in a manner and the form which facilitates the Right to Information under this Act and ensure that all records that are appropriate to be computerized, within a reasonable time and subject to availability of resources, computerized on connect through a network all over the Country on different systems.
