

APPEAL CASE NO. 2384 OF 2020

During the hearing dated 04.11.2020, the Appellant had stated that incomplete information had received by him whereas the Respondent had stated that information had been supplied to the Appellant vide letter dated 29.10.2020 through registered post. He had also orally stated that remaining information (Intkaals) is available with the Suvidha Kendra and he could get the same by depositing the requisite fee as per policy of the Government of Punjab. Therefore, he was directed to get the information after depositing the requisite fee. The matter was adjourned to 22.12.2020.

During the hearing dated 22.12.2020, the Appellant reiterated his earlier version whereas the Respondent had stated that the Appellant had been asked to deposit the fee of Rs. 2720/- for supply of information, which he has not been deposited till date. The Appellant was again directed to deposit the requisite and the matter was adjourned to 02.03.2021.

The case has been heard today through CISCO Webex. The Respondent reiterates his earlier version that the Appellant did not deposit the documentation fee whereas the Appellant is absent.

After examining the case file, it is revealed that the Appellant had filed an RTI application dated 31.05.2020 with the PIO O/o Deputy Commissioner, Barnala. The Respondent – PIO O/o D.C. Barnala mentioned in his reply that the RTI application of the Appellant was received on 11.06.2020 and since the information relates to the Tehsildar, Tappa, as such, the same has been transferred u/s 6(3) of the RTI Act vide letter dated 12.06.2020. After that, PIO O/o Tehsildar, Tappa wrote a letter to the Appellant on 10.07.2020 and asking him to deposit the documentation fee of Rs. 2720/- with concerned revenue authorities after inspecting the relevant official records. However, the Appellant did not avail of the opportunity so provided to him and also failed to deposit the fee as directed by the Bench. It is presumed that the Appellant is not interested to getting the information.

In view of the position brought out above, the Bench agrees with the contention of the PIO O/o D.C., Barnala and PIO O/o Tehsildar, Tappa and the Appellant is directed to get the information sought by him from the concerned revenue authorities after depositing requisite fee as prescribed by the Government of Punjab.

With the aforesaid directions, the Appeal case is **disposed of and closed.** Copies of the order be sent to the parties.
