However taking a lenient view, one last opportunity is given to the respondent to appear before the Commission and state his case, failing which action under Section 20 (1) of the RTI Act will be initiated.
- 4. To come up on **15.06.2022 at 12.00PM** for further proceedings in the Commission. Copy of the order be sent to the parties.
