Viney Kapoor Mehra and later on the case file was sent to the Bench (SIC/ASK) for hearing.

Today, Dr. Shivraj Singh appellant is present, but none has come present on behalf of the PIO, O/o Director, Ayurveda, Punjab.

So, the PIO, O/o Director, Ayurveda, Punjab is directed that information sought by the appellant through his RTI application dated 11.09.2018 be provided to him by hand or
