2. The notice of hearing was issued to the parties for 02.05.2022. Shri Rinku, appellant comes present to attend the hearing in person before the Bench. He states that he has sought copy of attendance as well sports achievement of the wrestlers trained by Shri Jaspreet Singh, Wrestling Coach during the period 2016 to 2019, which has not been provided so far.
3. Shri Raj Kumar, Clerk O/o District Sports Officer, Ludhiana comes present to attend the hearing in person before the Bench. He states that reply has been sent to the appellant vide letter dated 22.04.2022 stating that the attendance of players is not submitted in the office of District Sports Officer by name and only the number of players as per monthly schedule of the Coach concerned is informed to the office and so far as the copies of sports achievement is concerned, these documents being personal documents, no record relating to the same is available in their office.

4. Shri Hardeep Singh Wadhwa, Advocate also attends the hearing on behalf of the PIO in person and states that the Coaches are outsourced employees and the diet money is disbursed on the basis of number of players coached by the Coach and no attendance record is available in the office of District Sports Officer, Ludhiana.

5. Post deliberations, the Bench observes that it is not in agreement with the issues brought forth by the respondent. The Bench directs that information as sought by the appellant be provided as per issues raised by him in his RTI application. Attendance details of players and performance/ achievements of the Wrestling Coach be given.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 02.08.2022 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
