ORDER:

This order may be read with reference to the previous order dated 26.02.2020.

2. The Appellant states that incomplete and unattested information has been supplied to him by the Respondent – PIO. He further states that compensation amount of Rs.3000/- has not been paid to him by the Respondents till date.
