The Commission has received a mail sent by the PIO on 27.05.2020 diarized vide no. 5925, which is a copy of letter no. 48708 dated 26.05.2020 along with the copy of information. I have gone through the said letter/information.

Advocate Vikas Kumar who is present on behalf of the appellant stated that incomplete information has been provided to the appellant.

So, the PIO is directed that the complete information as was sought by the appellant through his RTI application dated 16.08.2019 be provided to him within a week, otherwise, show cause notice will be issued to the PIO.

Both the parties be personally come present before the Commission on the next date of hearing on **07.07.2020 at 11:00 A.M.**
