ORDER

This order may be read with reference to the previous order dated 22.2.2021 vide which the case was adjourned for 26.3.2021 but due to administrative reasons the case was further adjourned for 28.4.2021 and for today i.e. 2.6.2021.

2. The appellant states that no information has been provided by the respondents so far. None is present on behalf of the respondents. Also no submissions have been received from the respondents. Viewing the attitude in dealing with the RTI application of the appellant, Sh. Rajneesh Garg 7986875019 Public Information Officer-cum Executive Officer, Block Samiti, Patran, is thus issued a **show cause notice** to explain in a self-attested affidavit as to why a compensation to the appellant for detriment suffered by him under section 19(8) of the RTI Act, 2005 may not be awarded.

3. In addition to the written reply, the Public Information Officer is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before awarding the compensation on the next date of hearing. He may take a note that in case he does not file his written reply and do not avail himself of the opportunity of personal hearing on the next date, it will be presumed that he has nothing to say and the Commission will proceed ex-parte.

4. One last opportunity is granted to the respondent-Public Information Officer to supply the complete information to the appellant before the next date of hearing under intimation to the Commission failing which the case will also be recommended for disciplinary proceedings as well as the penalty provisions will be invoked on the next date of hearing.
