**ORDER**

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 21.12.2019. First appeal is dated 06.02.2020. Second appeal has been received in the Commission on 15.06.2020.

On the last date of hearing, held on 10.05 .2021,

- i) Dr. Baldev Singh, Joint Director-cum-PIO(Inputs) stated that the requisite information of six pages (after collecting the same from Statistical Officer and Establishment – 2 Branch) was sent to the appellant vide letter dated 09.03.2021 through registered post.

#### ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.  
The RTI request is dated 15.07.2020. First appeal is dated 21.08.2020. Second  
appeal has been received in the Commission on 05.11.2020.

On the last date of hearing, held on 10.05.2021,

- i) Sh. Satnam Singh, A. S. I, stated that the requisite information was supplied to the appellant.
- ii) The appellant, Ms. Kamaldeep Kaur, stated that she received only a reply from the respondent but not received the required information in the instant appeal-case as she demanded action taken report on a complaint filed through telephonic message.
