**ORDER:**

The case was first heard on 17.08.2020. The respondent present pleaded that regarding points 1, 2 & 4, the appellant was asked to deposit the requisite fee of Rs.1866/- for 933 pages and get the information but the appellant has not deposited the same. The appellant was directed to inspect the record relating to Points 1,2& 4 and get the relevant information by depositing the requisite fee as per RTI Act.

The respondent further informed that the information regarding points 3 & 5 is not available with them since the refund is being made by the Excise & Taxation Department and the payment is being released to the beneficiaries through the RBI account.

The appellant was not satisfied. The appellant had simply asked that from which Govt accounts, a beneficiary is disbursed the GST/VAT. The PIO was directed to check under whose custody the information regarding point-3 lies, procure it and provide the information to the appellant. Regarding point-5, the PIO was directed to transfer the RTI application to the Department of Excise & Taxation Punjab. The PIO Department of Excise & Taxation, Punjab was directed to look at the RTI application and provide the information to the appellant. A copy of the RTI application was attached with the order for the PIO-Department of Excise & Taxation.

On the date of the last hearing on **27.01.2021**, the respondent present from the office of District Treasury Officer informed that they have already provided the information concerning them and transferred the RTI application to the Department of Excise & Taxation, Punjab Ludhiana for information relating to point-5.

None was present from the Department of Excise & Taxation. The letters issued to them on 17.09.2020 & 24.10.2020 at the address provided by the District Treasury Officer had been returned back from the postal authorities with the remarks "insufficient address", whereas the order dated 17.08.2020 appeared to have been delivered.
