- 1. The RTI application is dated 08.01.2020 vide which the appellant has sought information as enumerated in his RTI application. The appeal was filed in the Commission on 03.07.2020 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. Notice of hearing was issued to the parties for 02.09.2020 by the Commission through Video Conferencing facility in the office of D.C. Kapurthala.
- 3. The case has been heard today through Video Conferencing in the DC Office, Kapurthala. The complainant Shri George Subh attends the hearing. He states that he has sought information regarding the particulars of S.C. category employees working in Punjab Roadways, Jalandhar-I Depot. He has been provided only the number of officers/ officials belonging to S.C. category working in Punjab Roadways, Jalandhar-1 Depot, without specific details of every individual as asked for in his RTI application.
- 4. Shri Gaurav Suri, Senior Assistant O/o G.M. Punjab Roadways, Jalandhar-I depot comes present to attend the hearing. He states that the information asked for by the complainant amounts to preparation of information which may take some time.
- 5. Post deliberations, the Bench observes that such details would be available on the website of the Department from where the complainant can be made available the information. The Bench directs the PIO to call the complainant to his office on any working day and make available the complete information

within next seven days. Shri Gaurav Suri gives assurance of providing the information within the specified time. Shri George Subh, on the assurance of representative of the PIO, agrees to close the case and does not seek another hearing.

6. With the aforesaid directions, **the complaint case is disposed off and closed.** Copies of the order be sent to the concerned parties.
