**ORDER:**

1. The RTI application is dated 20.06.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.07.2022 and the second appeal was filed in the Commission on 15.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 02.11.2022. Accordingly, the case has been heard today. Shri Rajinder Kumar, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. Shri Navdeep Sharma, Vigilance Officer O/o Director, Local Govt., Punjab comes present to attend the hearing in person before the Bench and states that the appellant had made three complaints dated 10.03.2022, 10.03.2022 and 31.03.2022 and complaint dated 10.03.2022 was not received in the Local Govt. 1. The RTI application is dated 11.02.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 24.05.2022 and the second appeal was filed in the Commission on 15.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 02.11.2022. Accordingly, the case has been heard today. Shri Vinay Kumar Singla, appellant has not come present to attend the hearing in person before the Bench or through cisco webex.
3. Smt. Sheenu Jindal, Junior Assistant, Patiala Development Authority, Patiala comes present to attend the hearing in person before the Bench and states that information has been supplied to the appellant on 04.05.2022 by registered post and that the position with regard to the information sought by him was also clarified to him vide letter dated 21.04.2022. 5. The Bench is convinced that adequate information has been supplied to the appellant and the grievance regarding issuance of NOC relates to executive action on the part of the Respondent.

6. In view of the above, the Bench does not feel need for further intervention in the matter.

**ORDER:**

1. The RTI application is dated 30.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 04.07.2022 and the second appeal was filed in the Commission on 16.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 02.11.2022. Accordingly, the case has been heard today. Shri Navneet Singh, appellant comes present to attend the hearing through cisco webex. He states that he has received partial information and he is not satisfied with the information supplied.
3. Neither the PIO O/o Director, Local Govt., Punjab has come present in person before the Bench nor through cisco webex. However, a letter dated 28.10.2022 has been received by post from the PIO-cum-Superintendent, Municipal Service Cell stating that information has been supplied to the appellant on 14.07.2022. The perusal of the letter shows that the information sought by the appellant

relates to Local Govt. Branches-1, 2 & 3, Superintendents of Establishment, General Branch, Trust Services Cell of the office of Director, Local Government, Punjab and RTI application has been transferred to all of them. This shows that the information sought by the appellant involves multiple PIOs.

4. The Bench apprises the appellant of the contents of letter dated 28.10.2022 that multiple PIOs are involved in the information sought by him. The appellant is clarified that in view of the decision of Full Bench of State Information Commission, Punjab in Complaint Case No.2903 of 2011 decided on 13.01.2012, the Bench does not entertain such RTI applications as it amounts to wastage of time of the public authorities involved as also the Commission. Then the appellant requests that PIO be directed to supply him the list of selected candidates against the advertisement mentioned in his RTI Application.

5. The Bench acceding to the request of the appellant, directs the PIO O/o Director, Local Government, Punjab to supply list of selected candidates against advertisement issued in 1998 under intimation to the Commission within fourteen days.

5. With the aforesaid directions, **the instant appeal case is disposed off and closed.**

**ORDER**

1. The RTI application is dated 17.02.2022 vide which the Complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 16.09.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 02.11.2022. The case has been heard today. Shri Karam Singh, complainant comes present to attend the hearing in person before the Bench and states that he has not received any information so far.
3. The PIO O/o GMADA, Mohali has not come present to attend the hearing in person or through cisco webex. However, a letter dated 26.10.2022 has been received stating that the PIO has been deputed for attending training programme in MGSIPA, Sector-26, Chandigarh and thus, is unable to attend the hearing today.
4. On the asking of the Bench, the complainant explains to the Bench the circumstances leading to the filing of Complaint Case by him in the Commission.
5. The Bench observes that the complainant has directly approached the Commission by preferring complaint in the Commission. The Bench further observes that the complainant has not availed the provision of Section 19(1) of the RTI Act by filing an appeal with the First Appellate Authority (FAA). As such, the FAA has not been able to address the grievances of the complainant. The attention of the Complainant is drawn to the decision of the judgment of Hon'ble Supreme Court of India rendered on 12.12.2011 in Information Commissioner and another Versus State of Manipur and another in para 31 whereof, it has been held that while entertaining a complaint case under Section 18 of the RTI Act, 2005,

the Commissioners have no jurisdiction to pass an order providing for an access to the information which is as under:-

31. We uphold the said contention and do not find any error in the impugned judgment of the Hon'ble High Court whereby it has been held that the Commissioner while entertaining a complaint under Section 18 of the said Act has no jurisdiction to pass an order providing for access to the information."

As such, since the complainant has approached the Commission under the provisions of Section 18 of the RTI, 2005, no directions for providing further information can be given by the Commission.

6. Since there is an alternative and efficacious remedy of First Appeal available to the Complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant complaint case and the First Appellate Authority has not had the occasion to review the decision of PIO, as envisaged under the RTI Act by passing a detailed well reasoned speaking order.

7. The instant matter is remanded back to the **First Appellate Authority i.e. Estate Officer (Policy), GMADA, Mohali**. The Commission hereby directs the FAA to treat the copy of the Complaint (enclosed herewith) as the First Appeal and decide the matter in accordance with the provisions of the RTI Act after giving all concerned parties an opportunity to be heard. He is directed to hear the complainant within ten days and decide the matter.

8. In case, the complainant is not satisfied with the decision of the First Appellate Authority (FAA), he is at liberty to file second appeal before Punjab State Information Commission Section 19(3) of the RTI Act, 2005.

9. In view of the above, **the case is disposed off and closed**. Copy of the order be sent to the parties.

1. This order may be read with reference to the order dated 04.10.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Jagtar Singh, appellant comes present to attend the hearing in person before the Bench. He states that no information has been supplied to him by the PIO.
3. Shri Vishal, Junior Assistant O/o Executive Officer, Municipal Council, Hariana, District Hoshiarpur comes present to attend the hearing in person before the Bench and states that information is not being accepted by the appellant. Then, on the asking of the Bench, he hands over the same to the appellant in the court itself. He, however, states that position has not been made clear on certain points.
4. The Bench directs the representative of PIO and the appellant to sit together in the adjacent court room, and the representative of PIO is directed to explain the position on each point of RTI application to the appellant and thereafter, appear again before the Bench.

5. Thereafter, both the appellant and respondent appear before the Bench and the appellant still expresses his dis-satisfaction and states that he has been put to a lot of harassment by the respondent in his effort to obtain information. As per position explained by the appellant, the Bench feels that it is a just case for the award of compensation and awards a compensation of **Rs.5,000/-(Rupees Five thousand only)** to the appellant. The compensation amount must be paid by the respondent PIO O/o Municipal Council, Haryana, District Hoshiarpur through cheque or demand draft in favour of Jagtar Singh from the account of the public authority and not from the individual's account. He is also directed to send a photocopy of the cheque or draft to the Commission as evidence for having paid the compensation.

6. On the asking of the Bench, the representative of PIO states that the information as available in the official records has been supplied to the appellant. The Bench now directs the PIO to file an affidavit on e-stamp paper, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.2937/2022 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

7. With the aforesaid directions, the instant appeal case is disposed off and closed. Copies of the order be sent to the concerned parties. The case file be sent to the Deputy Registrar, PSIC to ensure compliance of the direction of the Bench i.e. reply to show cause notice, deposit of penalty amount of Rs.5000/- as also filing of affidavit, as directed by the Bench.
