This order may be read with reference to the previous order dated 4.11.2020.

- 2. The representative of the respondents states that the complete information as available on record has already been supplied to the appellant. However, the appellant states that he has received the information except the copy of mustroll pertaining to April, June, July(half) and August,2019 that relates to his own work and he signed the mustroll but no payment has been received. But the representative of the respondents states that he has already supplied the copy of mustroll as available on record showing that he did not done any work during the period.
- 3. The perusal of the file shows that a show cause notice was issued to the respondent-Public Information Officer on 4.11.2020 that why a compensation to the appellant for detriment suffered by him under Section 19(8) of the RTI Act, 2005 may not be awarded in this case. As the application for information was filed by the appellant on 9.12.2019 but after lapse of more than eleven months, complete information has not been provided to the appellant so far. It is, thus apparent from the response of the respondent-Public Information Officer that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act.
- 4. I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 5000/- (Rupees Twenty Five hundred only) by way of compensation to the Appellant. This amount shall be payable from the State Exchequer before the next date of hearing.
- 5. The District Development and Panchayats Officer is also advised to look into the matter personally and in case he feels that injustice has been done to the appellant, the matter may be enquired as enumerated in para 2 above.
