ORDER:

The complainant through RTI application dated 17.02.2020 has sought information regarding a Copy of report No.1549 dated 02.09.2019 in respect of the case of Savita Kumari V/s Rajat Sahotra under DV Act 2005 submitted by CDPO-II Amritsar to the court of Smt.Ambika Sharma JMIC District Court, Amritsar and other information as enumerated in the RTI application from the office of Department of Social Security and Development of Women and Children, Pb Chandigarh. The complainant was not satisfied with the reply of the PIO dated 28.02.2021 after which the complainant filed a complaint in the Commission on 18.03.2021.

The case was last heard on 08.09.2021 through video conferencing at DAC Mohali. The complainant claimed that the PIO has not provided the information.

The respondent was absent without any legitimate reasons for the absence.

Having gone through the reply of the office of Child Development Project Officer, Amritsar, in which the officer has simply denied the information by invoking section 8(1) of the RTI Act was found vague since in the reply, there was no speaking order that why the officer has chosen to use this exemption.

Given the above, there was prima-facie evidence of PIO denying the information intentionally.

The PIO was issued a **show-cause notice under Section 20 of the RTI Act 2005 for not supplying the information deliberately and holding the information mala-fidely and directed to file a reply on an affidavit.**

Hearing dated 03.01.2022:

The case has come up for hearing today through video conferencing at DAC Mohali. Both the parties are absent.

The Commission has received a copy of a letter dated 11.10.2021 of the Joint Director-cum-PIO O/o Director Social Security and Development of Women & Children vide which the Joint Director has directed the PIO-Child Development Project Officer, Amritsar Urban-2 to appear before the Commission on 03.01.2022 alongwith all documents.

Earlier order stands. The PIO is directed to comply with the earlier order of the Commission which still stands and appear personally before the Commission on the next date of hearing along with the reply to the show-cause notice on an affidavit. PIO to also inform who was the PIO at the time of filing of RTI and on the date of issue of show cause notice.

The case is adjourned. To come up for further hearing on **19.04.2022** at 11.00 AM through video conference facility available in the office of Deputy Commissioner, Mohali.

ORDER:

The complainant through the RTI application dated 30.11.2020 has sought information regarding not considering the child of a freedom fighter on the post of Medical Lab Technician Grade-2 under 1% Freedom Fighter Quota against 98 posts advertised on 13.07.2020 and other information as enumerated in the RTI application from the office of Director Health and Family Welfare, Pb Chandigarh. The complainant was not provided with the information after which the complainant filed a complaint in the Commission on 30.03.2021.

The case last came up for hearing on 08.09.2021 through video conferencing at DAC Faridkot/Mohali. Due to a technical fault in the VC, the hearing could not take place.

The Commission received a copy of a letter dated 06.08.2021 from the PIO through email which was taken on the file of the Commission. Vide this letter, the PIO had sent a reply to the complainant that the information being in question form, cannot be provided under the RTI Act.

Hearing dated 03.01.2022:

The case has come up for hearing today through video conferencing at DAC Faridkot. As per the complainant, the PIO has not supplied the information.

As per the letter dated 05.10.2021 received from the Superintendent (RTI Branch), the RTI application of 30.11.2020 was transferred to the Superintendent (Establishment-7) Branch on 28.01.2021.

As per record, the reply was sent by the PIO-cum-Suptd.(E-7) to the appellant on 06.08.2021. From these facts there is prima facie evidence that there has been a delay of more than seven months in attending to the RTI application, which is a violation of Section 7 (1) of the RTI Act. The Commission has taken a serious view of this and hereby directs the PIO to **show cause why penalty be not imposed under section 20 of the RTI Act 2005 for not transferring the RTI application in a proper way and secondly for not supplying the information within the statutorily prescribed period of time. He/she should file an affidavit in this regard.** If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such person(s) of the show cause and direct them to appear before the Commission along with the written replies.

ORDER:

The appellant through RTI application dated 20.01.2020 has sought information regarding action taken on the application filed for cancellation of probation period of Ramesh Kumar and Prem Chand – action taken on the complaint dated 13.11.2019 for missing record by Ajay Singh Clerk - and other information as enumerated in the RTI application concerning the office of Addl.Chief Secretary Local Govt. Punjab Chandigarh. The appellant was not provided with the information after which the appellant filed the first appeal before the first appellate authority on 19.02.2020 which took no decision on the appeal.

On the date of the last hearing on **16.08.2021**, the respondent present pleaded that the information relating to point-9 concerning them was denied u/s 8(H) since the matter was under consideration with the Govt. and the reply was sent to the appellant on 13.03.2020. Thereafter, on the recommendation of DC Faridkot, show cause notice was issued to all the employees found responsible and a reply was sent to the appellant vide letter dated 30.07.2021. Further, since the remaining information related to the office of Director, Local Govt., the RTI application was transferred to them u/s 6(3) on 06.03.2020. The PIO-Director Local Govt has also sent information to the appellant vide letters dated 27.02.2020 and 19.03.2020.

The appellant was not satisfied with the information provided and wanted information regarding the action taken by the Principal Secretary Local Govt. on his applications as mentioned in the RTI application.

The PIO was directed to relook at the RTI application and provide whatever action has been taken by the Principal Secretary on the applications of the appellant along with all noting/correspondence. The PIO was also directed to file a reply to the show-cause notice.

Hearing dated 03.01.2022:

The case has come up for hearing today through video conferencing at DAC Faridkot/Mohali. As per the respondent, the information has already been provided to the appellant.

As per the respondent, the PIO has not yet provided the copy of his complaints alongwith action taken by Principal Secretary Local Govt. thereon as mentioned in the RTI application.

Hearing both the parties, the PIO is directed to provide information as per earlier order, which still stands and as discussed during the hearing. The PIO is also directed to file a reply to the show-cause notice.

To come up for further hearing on **19.04.2022 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, Faridkot. The PIO to appear at Chandigarh.

ORDER:

The case has come up for hearing today through video conferencing at DAC Faridkot. The respondent present pleaded that in compliance with the order of the Commission, the information has already been provided to the appellant but the appellant has not communicated any discrepancies.

At the last hearing, the respondent had brought a set of information and a copy of the same was sent to the appellant with the direction to point out the discrepancies to the PIO with a copy to the Commission and the PIO was directed to remove the same. The appellant has not communicated any discrepancies.

Now the appellant claims that the information is incomplete.

Having gone through the RTI application and hearing both the parties, the following is concluded:

- Point-2,3 & 4 - Information provided
- Point-5 - As per the respondent, the information relates to the Admn wing. The PIO is directed to transfer the RTI application under section 6(3) to the Admn Wing and the PIO-Admn Wing is directed to provide information on point-5.
- Point-6 - As per the respondent, the information is voluminous and the appellant be asked to specify the complaint or inspect the record and get the relevant information.

The appellant is directed to specify the complaint or inspect the record and get the relevant information.

The PIO is also directed to file a reply to the show-cause notice.

The case is adjourned. To come up for further hearing on **19.04.2022 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, Faridkot. The PIO to appear at Chandigarh.
