ORDER

This order may be read with reference to the previous order dated 27.02.2020 vide which Dr. Beerinder Kaur, SMO was directed to be present personally on the next date of hearing, i.e, today.

2. The Appellant states that the complete information has not been provided to him so far.

3. The perusal of the file shows that, on the previous date of hearing, Dr. Beerinder Kaur, SMO, was directed to be present personally alongwith the complete original record. Today neither she has appeared nor she has sent her reply. This clearly shows that the Respondent has no regard for the orders of the Commission.

4. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.5000/- (Rupees Five Thousand Only)** is awarded to the Appellant as compensation. I order accordingly.

- (i) Why supply of information as per RTI request sent to him has been delayed.

This order may be read with reference to the previous order dated 06.02.2020.

2. The Appellant states that he had inspected the record in the office of the Respondent but the complete record was not provided to him.

3. The Respondent states that the information demanded by the Appellant is very voluminous.

4. After perusing the file, it is ascertained that the information sought by the Appellant is very voluminous and there is the judgment of The Supreme Court of India in Civil Appeal No. 6454 of 2011 Central Board of Secondary Education Vs Aditya Bandopadhyay and ors. has in its judgment dated 09.08.2011 observed as under -

(37 Indiscriminate and impractical demands or directions under RTI Act for disclosure of all and sundry information (unrelated to transparency and accountability in the functioning of public authorities and eradication of corruption) would be counter-productive as it will adversely affect the efficiency of the administration and result in the executive getting bogged down with the non-productive work of collecting and furnishing information. The Act should not be allowed to be misused or abused, to become a tool to obstruct the national development and integration, or to destroy the peace, tranquility and harmony among its citizens. Nor should it be converted into a tool of oppression or intimidation of honest officials striving to do their duty.

The nation does not want a scenario where 75% of the staff of public authorities spends 75% of their time in collecting and furnishing information to applicants instead of discharging their regular duties. The threat of penalties under the RTI Act and the pressure of the authorities under the RTI Act should not lead to employees of a public authorities prioritising 'information furnishing', at the cost of their normal and regular duties.)

5. Hence, the Appellant is directed to point-out specific information, as required by him to the Respondent within one week, with a copy to the Commission. Accordingly, the Respondent is directed to provide the information to the Appellant.
