

been supplied up to 10.2.2020. He also states that the sought information pertaining to Point No. 3 has been sought up to date so the respondent-Public Information Officer may be directed to supply the information regarding 'IJLAS' up to date and the respondent-Public Information Officer assured that the same will be supplied to the appellant within four weeks.

4. The respondent-Public Information Officer has already paid the compensation amount along with the complete information except the copies of 'IJLAS' for which he has assured that the same will be supplied to the appellant within four weeks. Accordingly, the respondent-Public Information Officer is directed to supply the remaining copies of the 'IJLAS' within four weeks from the issue of this order and in case the appellant does not receive the same within four weeks, he is at liberty to approach the Commission within six weeks from the issue of this order. With these directions, the Commission observes that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
