"We hold that under Section (3) of the Act ibid, the legal obligation of a PIO who receives a request for information under Section 6(1) of the Act is limited to transfer this request to only one public authority that holds the information. This obligation does not extend to transfer to multiple authorities.

### Appeal Case No.: 2851 of 2021 Heard through CISCO Webex

- 6. The Bench advises the appellant to seek information by filing RTI application before a specific public authority who has its separate PIO in future. There is no such provision under the RTI Act to collect the information from the different offices of a public authority and then to compile and supply to the appellant.
- 7. The appellant is advised to visit the respondent's office on Monday i.e. 07.03.2022 to collect the information in connection with point no. 6. Further, the Commission does not see any further course of action required in this case and the case stands **disposed of/closed**. Copy of the order be sent to the parties.
