He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte."

The case has come up again for hearing today. It is very intriguing that the BDPO, Gur Harsahai, District Ferozepur is stubbornly maintaining silence on the directions and show cause notice of the Commission. The Commission finds that he had been advised by the District Development and Panchayat Officer, Ferozepur also to comply with the orders of the Commission. Though he does not deserve any relaxation yet in the interest of fair play another opportunity is afforded to him to file a written reply to the show cause notice failing which the penal action as proposed in the SCN shall be taken against him.

ORDER

The case has been heard through video conferencing.

The Commission had made the following order on 06.02.2019:

"The appellant has sent a communication seeking adjournment. Simultaneously, he says that he has appointed an attorney to represent him who is not present.

Sh. Amandeep Singh, BDPO, Rayya has come present in person. He submits that the information sought is colossal pertaining to four villages in his jurisdiction. The Panchayat Secretaries of the villages have intimated him the cost of providing information to the extent of Rs.4400/- approximately. He further says that the appellant claims the information free of cost being BPL copy holder. The respondent says that in such a scenario he can only be provided information costing up to Rs.50/- as per notification of the Punjab Government.



Appeal Case No.3564/2018

The Commission has carefully perused his application. At its mere sight it is suggested that an indiscriminate all and sundry information pertaining to a period of about ten years relating to various aspects of the functioning of the respective panchayats has been sought. The Commission is at a loss to understand as to how he would like to serve the public cause with such a massive information. Seemingly it suggests a fishing and roving exercise on the part of the appellant. Nonetheless, in the interest of transparency the Commission directs him to confine the information only to a couple of years which he may identify. The respondents shall allow the inspection of record to the appellant for these years on mutually agreed date and time and shall deliver him the certified copies of the documents not beyond one hundred pages in respect of each panchayat."

The case is being taken up today. Sh. Chetan Sharma, Tax Collector, Block Rayya appearing on behalf of the respondents submits that the proxy counsel of the appellant was made to inspect the record in compliance with the aforementioned order and certified copies of documents to an extent of one hundred pages in respect of each Panchayat have been handed over to him. He submits that acknowledgement on this score has been issued by Sh. Lakhvir Singh which is available with them on record. The Commission has no reason to disbelieve it. The interim order having been complied, the Commission feels that the appellant has been sufficiently informed. No further intervention is called for. The appeal is **disposed**.
