- 4. The PIO, Ms. Amritpal Bhatti, District Commandant, Home Guards, Fatehgarh Sahib comes present. She states that initially the appellant was denied the information asked for by him vide letter dated 15.04.2020 on the ground that the information sought being third party, consent of the person concerned was needed and he had declined his consent for sharing the information. However, subsequently the First Appellate Authority –cum-Deputy Commandant General, Home Guards and Civil Defence, Punjab, Chandigarh vide his letter dated 06.07.2020, directed that the petitioner be provided the information. Same has been done vide their letter dated 29.07.2020. Then, the PIO, on the asking of the Bench, shows the letter to the appellant.. But the appellant shows his dissatisfaction over the information supplied.
- 5. The Bench examined and deliberated on the case in detail. The Bench observed that the information sought by the appellant was third party information and served no public activity or interest and thus the information has been rightly denied by the PIO. RTI Act Section 8(1)(j) refers.
- 6. In view of the above, the Bench feels that no further cause of action is left in the matter. **The appeal is disposed off and closed.** Copies of the orders be sent to the parties concerned.

5.
