ORDER:

This order should be read in continuation to the earlier order.

On the date of hearing on **21.05.2019**, the appellant claimd that despite order of the Commission, the PIO neither provided the information, nor cooperated to inspect the record. The respondent was absent. The PIO was issued a show cause notice under section **20** of the RTI Act and directed to file reply on an affidavit. The PIO was also directed to bring the record regarding information relating to points 6 & 7 to the Commission on the next date of hearing.

On the date of hearing on 17.07.2019. The appellant was absent. The respondent present from the office of Warehousing Corporation pleaded that the matter does not relate to them and he has been ordered to attend the hearing only. The PIO was absent nor had sent any reply to the **show cause notice**. The PIO was granted one last opportunity to comply with the earlier order of the Commission and appear personally before the Commission on the next date of hearing alongwith written reply to the show cause on an affidavit.

On **29.10.2019**, the respondent present pleaded that the information has already been sent to the complainant. The PIO however, did not submit reply to the show cause notice issued on 21.05.2019. The complainant was absent.

On the next date of hearing on **23.12.2019**, the respondent present pleaded that the information has been provided to the appellant. The appellant stated that the PIO has not provided copy of mortgage deed regarding point-6. The PIO was directed to provide the copy of mortgage deed and if not available to give in writing on an affidavit. Rest of the information had been provided. The PIO however, did not submit reply to the show cause notice issued on 21.05.2019. The PIO was directed to submit reply to the show cause notice on an affidavit.

On the last date of hearing on **17.03.2020**, the respondent present pleaded that the information regarding point-6 (mortgage deed) is not available in the record. The PIO was directed to give this in writing on an affidavit. The Commission has received reply to the show cause notice from the PIO through email which was taken on the file of the Commission.

The complainant was absent and vide email had sought adjournment.

Complaint Case No. 1099 of 2018

Hearing dated 03.08.2020:

The case has come up for hearing today through video conferencing at DAC Sri Mukatsar Sahib. The respondent present pleaded that in compliance with the order of the Commission, an affidavit regarding information relating to point-6 has been given to the complainant.

The complainant however, pleaded that even though the information has been provided by the PIO, it is with a delay of more than two and half years. Henceforth, the PIO may be penalized and he(appellant) may be compensated for undue harassment in getting the information.

The information stands provided. However, the Commission agrees with the appellant that he had to suffer undue inconvenience to get the information, making it a fit case for awarding compensation to the appellant u/s 19(8)(b) of the RTI Act.

The PIO is directed to pay an amount of **Rs.5000/-** via demand draft drawn through Govt. Treasury as compensation to the appellant for the loss and detriment suffered by him of having to file the appeals and not getting information in time. The PIO is directed to duly inform the Commission of the compliance of the order and submit proof of having compensated the appellant.

The decision on the show cause notice issued to the PIO will be taken on the next date of hearing.

The case is adjourned. To come up for further hearing on **08.09.2020 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, Sri Mukatsar Sahib.

ORDER:

The case was first heard on 17.10.2019. The respondent present pleaded that since the information was voluminous, the appellant was called for inspection and after inspection, the appellant was asked to deposit a sum of Rs.390/- for 195 pages which the appellant did not deposit. The respondent present informed that this information relates to DC office.

Hearing both the parties, the Commission observed that there is delay in providing the information regarding points 3, 6 & 7 and these points have not been adequately replied. The PIO-SDM Malout was issued a **show cause notice under Section 20 of the RTI Act and directed to file reply on an affidavit.** The PIO was again directed to provide the complete information within 10 days of the receipt of this order.

The application was also marked to the First Appellate Authority, Deputy Commissioner, Sri Mukatsar Sahib for taking a cognizance on this application and to ensure compliance of order of the Commission.

ORDER:

The appellant through RTI application dated 22.07.2019 has sought information regarding subsidy released by PUDA from 01.04.2018 to 31.03.2019 against Roof Top Power Plant Grid and other information concerning the office of Punjab Energy Development Agency Chandigarh. The appellant was denied the information by the PIO vide letter dated 16.08.2019 after which the appellant filed first appeal before the First appellate Authority on 02.09.2019 which disposed off the appeal upholding the PIO's view.

The case was last heard on 26.02.2020. The appellant claimed that the PIO has not provided the information. The respondent was absent. The Commission received a letter on 13.02.2020 from the APIO stating that there is no list available on record for subsidy released against grid connected solar rooftop power plants.

The Commission found it hard to believe that there is no list of beneficiaries of subsidy for Roof Top Power Plant Grid and observed that the PIO has simply ignored the application in a cursory way. The PIO was directed to provide the information. The PIO was also directed to be present on the next date of hearing.

Hearing dated 03.08.2020:

The case has come up for hearing today through video conferencing facility at DAC Ludhiana. The respondent is present at Chandigarh office. The respondent has submitted the information to the Commission which is taken on record. After sifting through the information, I am of the view that since the information contains the names and addresses of many beneficiaries, the bench would like to understand from the appellant the larger public interest that lies in handling this information.

The appellant is directed to appear before the Commission on the next date of hearing and convince the Commission that the revealing of the information has a larger public interest.

ORDER: Facts of the case-

That the appellant Sh.Bharat Bhushan vide RTI application dated 27.08.2018 sought copy of noting dated 08.06.2017 – fixation of pay scale of JBT/ETT – present status of action taken, total expenditure of 6th pay commission incurred by the Govt and other information from the office of Secretary, 6th Pay Commission, Punjab, Chandigarh.

That the information was not supplied by the PIO, the appellant filed first appeal before the First Appellate Authority on 01.10.2018 and second appeal in the Commission on 20.11.2019 under section 19 of the RTI Act 2005.

That the case came for hearing before the Bench of Sh.S.S.Channy, CIC on 07.01.2019. Sh.Rajinder Singh, Section Officer appeared and informed that the information has been sent to the appellant vide letter dated 20.12.2018. The appellant was absent. The appellant was directed to go through the information and send his observations.

That on the next date of hearing which was held on 05.02.2019, the respondent was absent. The appellant vide letter dated 22.01.2019 sent deficiencies in the provided information and a copy of same was sent to the PIO with the direction to remove the same.

That the case was again heard on 13.03.2019. The PIO was again absent. The appellant vide letter dated 02.03.2019 sought exemption. Copies of both the letters dated 22.01.2019 and 02.03.2019 were sent to the PIO to supply complete information and directed to submit status report.

That on the date of hearing on 08.04.2019, the PIO was again absent. The appellant vide letter dated 29.03.2019 informed that the PIO has not replied/removed the discrepancies. The PIO was again directed to sort out the discrepancies before the next date of hearing.

That the case was further heard on by this bench on 23.10.2020. The appellant sought exemption due to ill health. The respondent was continuously absent. The PIO-Secretary, 6th Pay Commission, Punjab, Chandigarh was issued a show cause notice under section 20 of the RTI Act and directed to file reply on an affidavit. The PIO was again directed to sort out the discrepancies in the information.

Appeal Case No. 3983 of 2018

That on the date of hearing on 13.01.2020, the appellant vide letter received in the Commission on 07.01.2020 sought exemption and informed that the PIO has not provided the complete information. The respondent was absent. The PIO was given one last opportunity to provide the complete information to the appellant and be present on the next date of hearing alongwith written reply to the show cause notice on an affidavit.

That on the date of last hearing on **03.03.2020**, **the** PIO was absent nor had sent any reply to the show cause notice. The appellant vide email sought exemption due to illness. The case was adjourned.

That the case has come up for hearing today through video conferencing facility at DAC Ludhiana. The appellant informed that the PIO has not provided the information. The respondent is continuously absent.

Keeping the above-mentioned facts of the case, it is clear that the PIO-Secretary, 6th Pay Commission, Punjab is flouting the spirit of the RTI Act continuously. The PIO has not only shown utter disregard for the Commission's repeated orders to provide the information but has shown willful stubbornness in not replying to the Show Cause and not appearing before the commission despite various orders of the Commission.

To secure an erring PIO's presence before the commission the Information Commission is empowered to issue warrants to Under Section 18(3) of the RTI Act. A bailable Warrant of the PIO-Secretary, 6th Pay Commission, Punjab, Chandigarh is hereby issued through Senior Superintendent of Police, Chandigarh for his presence before the Commission on **23.09.2020**.

To come up for further hearing on 23.09.2020 at 02.00 PM through video conference facility available in the office of Deputy Commissioner, Ludhiana. The PIO to appear at Chandigarh.

Due to non compliance of the order of the Commission, the PIO- Tehsildar Village Gill (Ludhiana) was issued a show cause notice on 13.03.2019 under section 20 of the RTI Act and directed to file reply on an affidavit.

On the next date of hearing which was held on 14.05.2019 and again on 03.07.2019, the PIO however in spite of the orders of the Commission to be personally present did not turned up nor had sent any reply to the show cause notice. Invoking section 20 of the RTI Act, a penalty of **Rs.15,000/-** was imposed upon the PIO, Tehsildar, under whose jurisdiction the Village Gill (Ludhiana) falls, which was be deposited in the Govt. To get the order served to the concerned PIO and to ensure compliance of this order, as well as ensure that the concerned PIO appears personally at the next date of hearing.

On the next date of hearing which was held on **13.08.2019**, **Sh.Harvinder** Singh, reader to Tehsildar(South) Ludhiana appeared and pleaded that neither the RTI application nor any order of the Commission was received by them and they only received the order dated 03.07.2019 through the office of DC Ludhiana. The respondent also submitted a letter dated 09.08.2019 signed by the PIO-cum-Tehsildar, Ludhiana(South) whereby the Tehsildar Ludhiana(South) informed that he has just joined on 05.07.2019 and as per their record, no RTI application pertaining to this appeal case was pending nor any order of the Commission was received.
