ORDER

1. The RTI application is dated 23.01.2021 whereby the information-seeker has sought information as mentioned in his RTI application. He filed complaint in the Commission on 03.03.2021 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for 03.08.2021 through CISCO Webex application.
2. Respondent, Sh. Sanjeev Singla states that information is not compiled at one place and creation is not permissible as per RTI Act, 2005.
3. Complainant, Sh. Sandeep Pathak left the meeting in between during hearing of this case.
4. From perusal of the record as available on the file, it is ascertained that the complainant has not availed the provision of the Section 19(1) of the RTI Act by filing an appeal with the First Appellate Authority (FAA). The Commission hereby directs the FAA to treat the copy of the Complaint (enclosed herewith) as the First Appeal and decide the matter in accordance with the provisions of the RTI Act after giving all concerned parties an opportunity to be heard.
