The RTI request is dated 03.03.2022. First appeal is dated 08.04.2022. Second appeal has been received in the Commission on 09.05.2022.

Sh. Krishan Dutt, Computer Operator(Recruitment Cell), who appeared (without 'authority letter'), on behalf of the respondent PIO in today's hearing, states that a reply has been sent to the appellant vide letter dated 05.05.2022 and a reply has been sent to the Commission vide letter no. 321 dated 29.07.2022, which has been received in the Commission vide Diary No. 16992 dated 01.08.2022. It is taken on record. Both the above-said replies are taken on record.

The appellant, Sh. Happy, who appeared in person in today's hearing, states that through that reply he is intimated that the information can not be provided to him under Section 8 (b) of the RTI Act.

After examining the reply sent by the respondent and finding it not acceptable, an opportunity is given to the appellant to visit office of the respondent on10.08.2022 at 12:00 P. M. to inspect the relevant official-record and identify the information.

The respondent PIO concerned is directed to facilitate the appellant during his visit to the office and supply the required information(which would be identified by him after inspection) to the appellant with a copy to the Commission.

An opportunity is also given to the appellant to confirm whether he has received the information or not. He is also advised to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO so that the same could be removed by the respondent concerned.

After examining the case-file, it emerges that the requisite information has not been supplied by the respondent PIO to the information seeker even after the directions were given by the Commission vide orders dated 29.06.2022. The Commission took a serious view of this casual approach of the respondent PIO.

In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to Public Information Officer concerned of office of Director, Deptt. of Local Government, Punjab (Recruitment Cell) Chandigarh as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant under the provisions of the RTI Act, 2005.

He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed in the office of State Information Commission, Punjab, Chandigarh, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte. A copy of this order be sent to him through registered post.

A copy of this order be sent to the Director, Deptt. of Local Government, Punjab, Chandigarh through registered post to ensure compliance of the above said order .
