He reiterates his statement made during the previous hearing that in spite of inspection of the records done by him and visits to the office of PIO twice, he has not been supplied information so far.
3. Neither the PIO has come present nor he has deputed any of his representatives to attend the hearing on behalf of the PIO nor any intimation has been received in this regard.
4. The Bench observes that the PIO or any of his representative has not attended the third consecutive hearing. He has also not complied with the directions of the Bench as neither the complete information, as identified by the appellant on inspection of records, has been supplied to the appellant nor reply to the show cause notice has been filed nor any evidence for having deposited the amount of penalty imposed on the PIO vide order dated 16.03.2021 has been sent to the Bench and the things still

remain the same in spite of the fact during the previous hearing, on the request made on behalf of the last opportunity was given to the PIO to comply with the directions of the Bench in its entirety. The Bench takes serious note of the same.

5. The Bench observes that though the RTI application is addressed to Commissioner, M.C. Ludhiana, but from perusal of RTI application, it is revealed the matter relates to the action taken regarding issuing of challans and imposition of penalty on the dairy owners in the residential areas of the city and the Medical Officer of Health is the concerned branch of Municipal Corporation, Ludhiana and Dr. Harbans Singh Dhalla, Sr. Veterinary Officer had attended the hearing on 01.06.2021 & 16.08.2021 and thereafter, Mr. Yaseen Sheikh, Veterinary Officer had attended the hearing on 15.11.2021 and thereafter, on next consecutive two hearings, none from the office of Medical Officer of Health has attended the hearing in the case in spite of the assurance given by the officers who attended the hearings to supply requisite information to the appellant.

1. This order may be read with reference to the order dated 04.05.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Surinder Pal Singh comes present to attend the hearing in person before the Bench on behalf of the appellant.

1. This order may be read with reference to the order dated 11.05.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Chanderdeep Maggu, appellant comes present to attend the hearing through cisco webex. He states that he has not been provided any information so far.
3. Neither the PIO has come present in person or through cisco webex nor he has deputed any of his representatives to attend the hearing on behalf of the PIO.

5. The PIO O/o O/o Executive Officer, Municipal Council, Fazilka is issued show cause notice to explain his absence as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for not supplying information to the appellant. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

5. In addition to the written reply, the PIO is hereby given an opportunity u/s 20(1) proviso thereto for personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

7. The PIO is directed to supply requisite information to the appellant before the next hearing as also to ensure to come present before the Bench in person on the next hearing, failing which the Bench will be constrained to issue bailable warrant to ensure his presence before the Bench.

8. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 08.09.2022 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.

4. Shri Gagandeep Singh Threke, appellant is contacted on mobile. He is made to talk to Shri Tarun Kumar, representative of PIO. The appellant also mentions to him the deficiencies pointed out. On the asking of the Bench, the appellant reiterates his version as made vide his e.mail dated 03.08.2022.

5. Post deliberations, the Bench directs the PIO to remove the deficiencies pointed out by the appellant and supply him rectified information before the next hearing. He is also directed to come present in person before the Bench on the next hearing.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 08.09.2022 at 11.30 AM in Commission's office at Chandigarh.** Copy of the order be sent to the parties.

ORDER

1. The RTI application is dated 05.03.2022 vide which the appellant has sought information as enumerated in her RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 11.04.2022 and the second appeal was filed in the Commission on 31.05.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 03.08.2022. Accordingly, the case has been heard today. Shri Gurwinder Singh, Assistant Estate Officer/PIO, GMADA, Mohali comes present to attend the hearing in person before the Bench and states that the information on point Nos.1 to 5 and 8 & 9 has been supplied to the appellant, whereas information on point Nos.6 & 7, being third party information, has not been provided. Reply has been forwarded vide letter dated 27.06.2022 by registered post, directly by the SDO(B)-cum-APIO, GMADA, Mohali.

4. The appellant is not satisfied by the inputs and requests for inspection of documents as also another hearing.

5. Post deliberations, the Bench directs the PIO to call the appellant to his office and allow the representative of appellant Shri Bharat Bhushan Mattu access to the relevant official records, by associating the concerned officials of Building Branch of GMADA. The information as may be identified by the representative of appellant, be supplied to him, before the next hearing. The appellant be also shown the record relating to point No.6 & 7 but no information, which is personal and third party related be provided.
