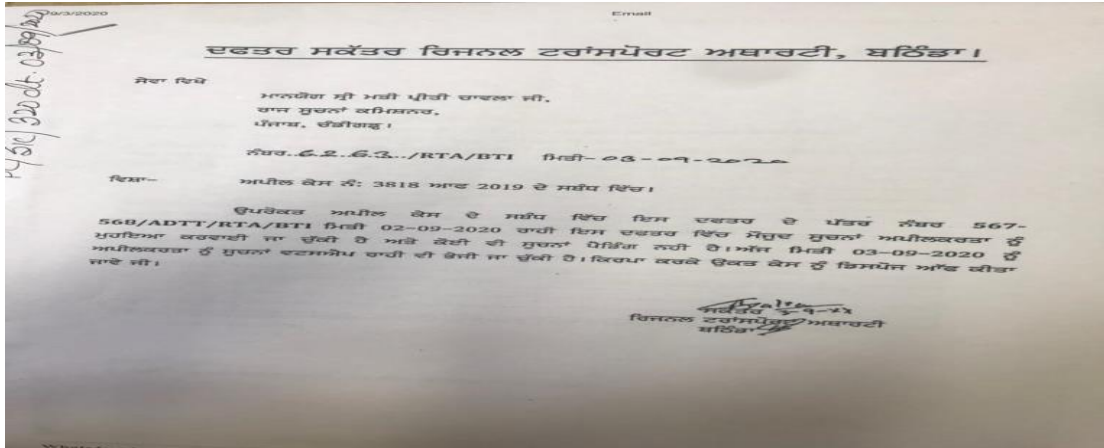
2. Today, the Appellant is not present today.
