### Appeal Case No. 1144 of 2020

Present:- Shri Neta Singh, appellant is present. Shri Rajan Gurbaksh Rai, PIO-cum-Asstt. Registrar, O/o Co-operative Societies, Gidderbaha is present.

ORDER

Shri Neta Singh, appellant filed RTI application dated 10.10.2019 and sought some information from the PIO, O/o Deputy Registrar, Co-op. Societies, Sri Muktsar Sahib.

#### Today the case is heard through CISCO WEBEX MEETINGS Software.

Both the parties are present today. The PIO stated that the sought for information/reply was sent to the appellant vide letter no.1345 dated 05.08.2020 and the copy of the same has been sent to the Commission also.

The appellant stated that he has received the information/reply, but he is not satisfied with it.

I have gone through the RTI application dated 10.10.2019 filed by the appellant before the PIO, O/o Deputy Registrar, Co-operative Societies, Sri Muktsar Sahib and he sought information regarding Co-operative Society, Village Kotbhai, Distt. Sri Muktsar Sahib.

I have discussed about the sought for information with both the parties, Shri Neta Singh, appellant and Shri Rajan Gurbaksh Rai, PIO-cum-Asstt. Registrar, O/o Co-operative Societies, Gidderbaha. The reply/information was sent to the appellant by the office of Asstt. Registrar, Co-operative Societies, Sri Muktsar Sahib vide letter no.1345 dated 05.08.2020 and a copy of the same is sent to the Commission, which is in the file of the Commission.

I have gone through the reply/information sent by the PIO. The information which was in existence with the office of the public authority i.e. Deputy Registrar/Assistant Registrar,

Co-operative Societies, Sri Muktsar Sahib, has been sent to the appellant and the information which is directly related with the Co-operative Society, Village Kotbhai does not exist in the office of the Deputy Registrar/Assistant Registrar, Co-operative Societies, Sri Muktsar Sahib.

So, after the perusal of letter no.1345 dated 05.08.2020 and after hearing both the parties, I am of the view that the PIO has rightly replied to the appellant and the information which was in existence with the office of the PIO has been sent to the appellant and the information which is directly related with the Co-operative Society, Village Kotbhai, the appellant is advised to get the information from the concerned co-operative society.

The PIO has rightly replied and provided the information to the appellant as per the law, so the present appeal case is **disposed of and closed**.
