1. This order may be read with reference to the order dated 24.08.2022 passed by this Bench on the previous hearing.

**ORDER:**

1. The RTI application is dated 11.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 17.05.2022 and the second appeal was filed in the Commission on 18.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 03.10.2022. Accordingly, the case has been heard today. Shri Rajwinder Singh, appellant comes present to attend the hearing through cisco webex.
3. SI Prem Singh and ASI Surinder Singh come present to attend the hearing in person before the Bench. SI Prem Singh states that the appellant has sought information on point No.1 to 6 for the period 01.01.2011 to 31.12.2020 regarding the complaints received at Police Post, Gujarpura, Police Station C-Division, Amritsar, which have not been entered in the register. The same was sent to the appellant vide letter dated 12.05.2022. He further states that the appellant had also filed First Appeal

before First Appellate Authority on 19.05.2022 and the First Appellate Authority, being in agreement with the information supplied by the PIO, had disposed of the first appeal. He further states that similar information was sought by the appellant vide Complaint Case No.213/2021 for the period 01.01.2014 to 30.11.2020 and Appeal Case No.2430/2021 for the period 01.01.2012 to 31.12.2012 and 01.07.2016 to 30.09.2016. Both the cases were disposed off by Hon'ble State Information Commissioner Shri Khushwant Singh. However, in those cases, information was sought regarding Misc. Complaints entry of which is made in the register. But in the present appeal case, information has been sought regarding unregistered complaints regarding which no information can be provided as no entries have been made in the register.

4. Due to disturbance in connectivity through cisco webex, the appellant is contacted on mobile phone and is made to talk to Shri Prem Singh who apprises him of the reply to his RTI application. Then the Bench talks to the appellant and the appellant expresses his dis-satisfaction over the reply of PIO.

5. Post deliberations, the Bench directs the PIO to call the appellant to his office and allow access to the appellant to relevant official records. The information as may be identified by the appellant be provided to him point-wise, before the next hearing and ensure to come present in person before the Bench on the next hearing.

6. The appellant is also directed to come present in person before the Bench on the next hearing, failing which the instant appeal case will be decided on the basis of available documents on file.
