5. In view of the above, Sh. Parminder Singh, Deputy Director-cum- *PIO o/o* Director, Department of Social Justice empowerment & Minority (Welfare Cell) is directed to show cause in writing or through affidavit under Section 20(1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/ denial of the information to the RTI applicant and why the compensation be not awarded to the complainant under Section 19 (8)(b) of the Act for detriment suffered.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

Twenty five thousand only) on the PIO. Therefore, taking a lenient view, I impose a penalty of **Rs. 5000/- (Rs. Five thousands only) on the concerned PIO- O/o DC, Ferozpur** . The Drawing and Disbursing Officer of the office of DC, Ferozpur is directed to deduct the amount of penalty of Rs. 5000/- from the salary of concerned **PIO-O/o DC, Ferozpur** and deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-

86-Fee under the RTI Act, 2005"
