The Appellant is not attends the hearing through Webex and he is subsequently he is contacted over mobile but his mobile phone is switched off/out of network coverage area.

The Respondent states that remaining information has already been supplied to the Appellant vide dated 21.10.2020 by registered post.

Last and final opportunity is given to the Appellant to follow up his case in the Commission, failing which appropriate decision shall be taken in his absence.

The case is adjourned for further hearing on **06.01.2021 at 11.00 AM** through **CISCO WEBEX meeting ID No.913428845**. Both the parties are directed to be present on the next date of hearing to present their case accordingly. Copies of the order be sent to the parties.
