## Appeal Case No.: 3255 of 2018

**Present:** Nobody on behalf of the appellant.  
For the respondent: Sh. Rajiv Kumar (ME), Sh. Varinder Kumar (AME) along with Sh. Kuljinder Singh (JE).

## ORDER

1. This order may be read with reference to the previous order dated 07.01.2020.
2. Appellant, Sh. Ramandeep Singh Ahluwalia is not present for today's hearing but an email dated 19.01.2020 has been received from the appellant by the bench of undersigned stating that he has visited the office of respondent's as per the previous order of the bench of undersigned dated 07.01.2020 but 8-10 persons stopped him and tried to contact the concerned officials but no response. This email is taken on record.
3. Appellant, Sh. Ramandeep Singh Ahluwalia also intimated the bench of Ld. SIC, Dr. Pawan Kumar Singla through telephonic message that he is unable to attend today's hearing and he has sent an email in this regard.
4. Another email dated 03.02.2020 has been received by the Commission from the appellant in connection with appeal case no. 3255 and 3256 of 2018 stating that again 8-10 unknown persons stopped his vehicle and threatened not to enter the premises of Municipal Corporation, which is taken on record.
5. On this, respondent, Sh. Rajiv Kumar states that appellant; Sh. Ramandeep Singh Ahluwalia had not visited the respondent's office on 20.01.2020 to collect the samples as per the previous order of the Commission dated 07.01.2020. He submits the following documents, which are taken on record:
  - A copy of letter no. 40/RTI dated 20.01.2020 signed by PIO-cum-EO, Nagar Council, Gobindgarh in connection with appeal case no. 3255 and 3256 of 2018 stating that appellant, Sh. Ramandeep Singh Ahluwalia had not visited to collect the samples from the Nagar Council, Gobindgarh dated 20.01.2020.
  - Reply dated 04.02.2020 signed by him in connection with Appeal Case No. 3255, 3256 of 2018 stating that nobody stopped the appellant and he does not have any information in this regard, which is taken on record in original in the present case.

- A copy of letter no. 29.01.2020 signed by the appellant dated 30.01.2020 stating that he withdraws his all RTI appeal cases, sample cases applications and all inspections filed with Municipal Council, Mandi Gobindgarh.

6. During the Court, it is observed that appellant, Sh. Ramandeep Singh Ahluwalia was present in the Commission and he was called by the staff of Ld. SIC, Dr. Pawan Kumar Singla to represent his cases but he refused to represent his cases before the division bench of undersigned.

7. After hearing the respondent and examining the documents placed on record, We are of the considered view that appellant, Sh. Ramandeep Singh Ahluwlia does not want the requisite information as he refused to represent his cases before the bench of undersigned though he was present in the Commission, which shows no respect to the Commission as well as of the Commissioners.

8. In wake of above, no further cause of action is left in this case. Hence, the instant appeal case is **disposed of & closed**.
