3. Representative of the appellant, Advocate Sunil Mallan states that incomplete information has been supplied to the appellant.
4. After hearing both the parties and examining the case file, It is observed that point-wise reply/information has already been supplied to the appellant except point no. 2 and 3 relates with Sh. Sanchit Kumar.

Respondent, Sh. Balwinder Singh handed over reply in connection with point no. 2 and 3 relates with Sh. Sanchit Kumar signed by him dated 04.06.2019, to the appellant during the hearing. A copy of the same is taken on record.
5. It is observed that supplied reply is satisfactory; no cause of action is required. Therefore, the instant appeal case is **disposed of & closed**.
