ORDER:

The appellant through RTI application dated 18.06.2020 has sought information regarding notices issued for demarcation fixed on 17.06.2020, 09.09.2019 & 20.07.2018 to the persons responsible for unauthorized encroachment of panchayat land as per the order of DC Patiala for getting the panchayat land vacated and other information as enumerated in the RTI application concerning the office of Naib Tehsildar Bhadson, Distt.Patiala. The appellant was not provided with the information after which the appellant filed a first appeal before the First Appellate Authority on 22.07.2020 which took no decision on the appeal.

The case first came up for hearing on 23.03.2021 through video conferencing at DAC Patiala. The appellant claimed that the PIO has not provided the information.

The respondent present pleaded that the notice dated 17.06.2020 & 20.07.2018 was marked by the DC Patiala to the Kanoongo and the report received from Kanoongo, was sent to BDPO, and the reply was sent to the appellant. The respondent further informed that the information presently is in the custody of BDPO Nabha.

The BDPO Nabha was absent.

Since there had been an enormous delay in providing the information and dilly-dallying regarding the custody of the information, the Commission appointed the SDM, Nabha as the deemed PIO in this case.

SDM, Nabha was directed to procure the information from whoever has the custody of the sought information and provide the same as per the RTI Act.

On the date of the next hearing on **09.06.2021**, the appellant claimed that the PIO has not provided the information.

SDM Nabha who was made deemed PIO under section 5 (5) of the RTI Act 2005 and directed to procure the information from the concerned authority and provide the same to the appellant, was absent nor had sent any communication.

There has been an enormous delay in providing the information. The PIO-SDM, Nabha was given one last opportunity to procure the information from the authority under whose custody the information lies, and provide it to the appellant as per the RTI Act otherwise the Commission will be constrained to initiate action under the provisions of section 20 of the RTI Act.

On the date of the last hearing on 28.09.2021, as per the appellant, the information was not supplied by the PIO.

The respondent present from the office of Naib Tehsildar, Bhadson informed that he appeared on the order of SDM office but he did not bring the sought information,

At the last hearing, SDM-Nabha was made deemed PIO under section 5 (5) of the RTI Act 2005 and directed to procure the information from the authority under whose custody the information lies and provide to the appellant.

The PIO-SDM Nabha was absent and had passed on the buck to provide information to some other officer, which prima-facie was a violation of the Commission's order whereby the SDM had been made the deemed PIO. The PIO-SDM Nabha was given one last opportunity to comply with the earlier order of the commission and procure the information from the custody of the concerned authority and provide it to the appellant within 10 days otherwise the commission will be constrained to issue show cause notice under section 20 of the RTI Act and take action accordingly.

Hearing dated 04.01.2022:

The case has come up for hearing today through video conferencing at DAC Patiala. Due to the non-presence of staff in the DC office Patiala because of the farmers' protest, the hearing could not take place.

The appellant vide email has informed that he has received the information but with a delay of more than 16 months and has pleaded for action against the PIO under the provisions of the RTI Act.

The case is adjourned. To come up for further hearing on **19.04.2022 at 11.00 AM** through a video conference facility available in the office of Deputy Commissioner, Patiala.

ORDER:

The appellant through RTI application dated 20.02.2020 has sought information regarding the joining date of JE Krishan Lal in Fatehgarh Sahib – a copy of bills of contractor Ajmer Singh Book No.01.06.15 to 31.10.2015 – a copy of bill book of contractor Davinder Singh, Randhir Singh – a copy of bill book of contractor Amandeep Singh and other information as enumerated in the RTI application, concerning the office of SDE Water Supply & Sanitation Division, Bassi Pathana. The respondent, however, had assured to provide complete information within 15 days.

ORDER:

The appellant Dr.Gurbachan Singh through RTI application dated 27.07.2009 address to Director (Education) SGPC Chandigarh sought information on seven issues relating to the interviews conducted for the post of Director(Education) SGPC Chandigarh. Having failed to get the information, he approached the State Information Commission. Notice was issued to the PIO for his appearance before the Commission on 22.10.2009. Sh.Balwinder Singh O/o Director (Education)-SGPC Chandigarh and Sh. Simarjit Singh-GPA-SGPC Amritsar appeared on the date of the hearing. Sh. Balwinder Singh O/o Director(Education) SGPC Chandigarh submitted a written reply vide letter dated 27.10.2009 that the SGPC being a religious body manage the affairs of the Sikh Community through a board/trust and is not covered under the purview of RTI Act since it is not financed by the Government.

The stand of respondent No.2 however, was that the information would be supplied to the appellant, for which he sought time. The case was adjourned.

On the date of hearing on 04.12.2009, it was concluded that the information sought in the present case does not pertain to any religious affairs, but relates to the selection process of the teachers recruited by the Directorate of Education, SGPC, there were no reasons to withhold the information and the PIO was directed to supply the information within a period of 15 days.

On the next date of hearing 22.12.2009, the respondent SGPC moved an application for review/recall/ modification of order dated 04.12.2009 which was decided and dismissed vide order dated 27.01.2009 and the PIO was directed to ensure that the information is supplied to the complainant as per order dated 04.12.2009.

On the date of hearing on 18.02.2010, since the PIO did not comply with the order of the Commission, a **show-cause notice** was issued to the PIO for non-supply of information and for violation of an order of the Commission.

Appeal Case No. 737 of 2009

On the date of the next hearing on 15.03.2010, Sh.I.P.S. Kohli, advocate along with Sh. Simarjit Singh, GPA-cum-PIO appeared on behalf of the respondent and submitted a copy of the order passed by Hon'ble Shri K.Kannan of Hon'ble Punjab and Haryana High Court in CWP No.4082/2010, whereby an interim order for stay was granted by the High court. Since the stay was granted and the case was pending in the High Court, the case was adjourned Sine-die on 27.08.2014.

The Hon'ble High Court in its order dated 04.07.2019 passed the following order:

"...... The court does not find any illegality in the impugned order passed by the Commission calling for interference. There being no merit in these writ petitions, the same, therefore, stand dismissed."

The case last came up for hearing before this Bench on 09.09.2021.

Since the writ petition filed by the respondent in the High Court for quashing of the order dated 14.09.2009 passed by the Commission was dismissed by the Hon'ble High Court, the order of the Commission dated 04.12.2009 still stands to be complied with by the PIO-SGPC, Amritsar.

However, the commission was of the view that since the RTI application was filed by the complainant in the year 2009, the complainant if still interested in the information was to file a suitable reply and appear before the Commission on the next date of hearing to pursue his case.

Hearing dated 04.01.2022:

The case has come up for hearing today through video conferencing at DAC Amritsar/Sangrur. The respondent present informed that they have filed LPA No.408/21 against the order of the Hon'ble High Court in CWP No.4082 which is fixed for hearing on 19.01.2022 and has sought adjournment.

On the next date of hearing 22.12.2009, the respondent SGPC moved an application for review/recall/ modification of order dated 04.12.2009 which was decided and dismissed vide order dated 27.01.2009 and the PIO was directed to ensure that the information is supplied to the complainant as per order dated 04.12.2009.

On the date of hearing on 03.03.2010, since the PIO did not comply with the order of the Commission, a show-cause notice was issued to the PIO for non-supply of information and for violation of the order of the Commission.

Simarjit Singh, GPA-cum-PIO appeared on behalf of the respondent and submitted a copy of the order passed by Hon'ble Shri K.Kannan of Hon'ble Punjab and Haryana High Court in CWP No.4082/2010, whereby an interim order for stay was granted by the High court. Since the stay was granted and the case was pending in the High Court, the case was adjourned Sine-die on 27.08.2014.

Complaint Case No. 2729 of 2009

The Hon'ble High Court in its order dated 04.07.2019 has passed the following order:

"...... The court does not find any illegality in the impugned order passed by the Commission calling for interference. There being no merit in these writ petitions, the same, therefore, stand dismissed."

The case came up for hearing last before this bench on 09.09.2021.

Since the writ petition filed by the respondent in the High Court for quashing of the order dated 14.09.2009 passed by the Commission stands dismissed by the Hon'ble High Court, the order of the Commission dated 04.12.2009 still stands to be complied with by the PIO-SGPC, Amritsar.

However, I am of the view that since the RTI application dates back to 2009, the complainant if still interested in the information, was directed to file a suitable reply and appear before the Commission on the next date of hearing to pursue his case.

Hearing dated 04.01.2022:

The case has come up for hearing today through video conferencing at DAC Amritsar. The respondent present informed that they have filed LPA No.408/21 against the order of the Hon'ble High Court in CWP No.4082 which is fixed for hearing on 19.01.2022 and has sought adjournment.

The complainant is absent nor is represented. The complainant vide letter received in the Commission has informed that being old, he cannot appear before the Commission.

The case is adjourned. To come up for further hearing on **09.05.2022** at 11.00 AM through video conference facility available in the office of Deputy Commissioner, Amritsar.
