This order may be read with reference to the order dated 29.09.2021 passed by this Bench on the previous hearing.

1. The case was scheduled to be heard today in Commission's office at Chandigarh. Shri Gaganpreet Singh, appellant has not come present to attend the hearing in person or through cisco webex.
