ORDER

The amount of penalty will be deposited in the Treasury of Punjab Government under the head.....

In addition, the PIO is also hereby given an opportunity under Section 20(1) provision thereto, for a personal hearing with the sought for information, before the imposition of such penalty on the next date of hearing.

The PIO/Respondent is directed to supply complete information to the Appellant, by registered post before the next date of hearing. As the Appellant is absent today so the representative of the Respondent/ PIO is directed to make a proper DD or cheque in the name of the Appellant through Government account and present the same to the Court on the next date of hearing.

In view of above, the Appellant is directed to appear in person and collect the same positively during the proceedings of the Court, on the next date of hearing.

Sh. Jaswinder Singh is directed to appear in person and bring the proper cheque/DD in the name of Harleen Kaur positively, on the next date of hearing.

The case is adjourned to next date of hearing which is fixed for 11.03.2020 at 11.00 A. M.
