The appellant is now again advised to visit the office of the respondent on any working day and peruse the original records as available in the office of the respondent with prior notice to the PIO. The respondent is directed to provide access to records in his office and give copies of documents needed by the appellant. Photocopies of the same be provided to him duly page numbered, stamped and authenticated by the PIO.

6. After deliberations and perusal of the record as available on the file, it is ascertained that the PIO is unnecessarily delaying provision of information and harassing the appellant. The RTI Act 2005 is meant to promote transparency in functioning of public authorities. The PIO is also absent in spite of the Notice of the Commission. The absence of the PIO is viewed adversely. The Bench directed the PIO to provide the complete and correct information to the appellant, free of cost, before the next date of hearing and personally appear on the next date of hearing, failing which action under Section 20(1) of the RTI Act, 2005 will be initiated.

7. The matter is adjourned. To come up for further hearing now on **04.03.2020 at 11.30AM**. Copies of the order be sent to the parties.
