The appellant after inspecting the record on 17.08.2021, asked for some more documents which have also been provided to the appellant vide letter dated 09.09.2021.

The Commission has also received a reply from the PIO on 24.09.2021 which has been taken on the file of the Commission.

The appellant is absent nor has communicated any discrepancies. It is presumed that the appellant has received the information and is satisfied.

Since the information has been provided, no further course of action is required. The case is **disposed of and closed**.
