When no information was provided to him by the SPIO, then he filed First Appeal before the First Appellate Authority on 19.08.2020 and then Second Appeal before the Punjab State Information Commission on 20.10.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today **through CISCO Webex Meetings Software.**

Ms. Sukhjinder Kaur, Advocate is present on behalf of the appellant. Smt. Amrit Pal Kaur, SPIO-cum-Suptd., O/o Home-4, Punjab, Chandigarh and Shri Jaswinder Singh, SPIOcum-Suptd. along with Shri Avtar Singh, Sr. Asstt., O/o Vigilance Deptt. (Branch-2), Punjab is present.

The counsel of the appellant stated that the sought for information has not been provided to the appellant.

Smt. Amrit Pal Kaur, SPIO-cum-Suptd., O/o Home-4, Punjab, Chandigarh stated that the information sought by the appellant does not relate with their office, rather it relates with the office of Vigilance Deptt. Punjab.

(Branch-2), Punjab stated that the appellant sought information regarding the minutes of the meeting held on dated 04.08.2014 and the reply regarding this has already been sent to the appellant vide letter no.68064/2020 dated 25.08.2020. He has submitted the copy of letter no. 68064/2020 dated 25.08.2020 along with some documents, which are taken in the file of the Commission.

I have gone through letter no. 68064/2020 dated 25.08.2020 and it is submitted by the SPIO that the action taken report regarding the meeting held on 04.08.2014 has been sent to the concerned departments for further action. It is further submitted by the SPIO that the Chief Vigilance Officers would submit the list of corrupt officers to their competent authorities, not to the Vigilance Department. It is further submitted that the report of four departments has been received and if the appellant needs the same, then he should deposit the requisite fee of Rs.45/- with the office of the SPIO.

The appellant filed RTI application on 10.07.2020 and the SPIO, O/o Vigilance Deptt. (Branch-2), Punjab has asked him to deposit the requisite fee of Rs.45/- vide letter no.68064/2020 dated 25.08.2020, which is after the lapse of stipulated period. So, the SPIO, O/o Vigilance Deptt. (Branch-2), Punjab is directed to send the attested copies of the report to the appellant, free of cost, through registered post within 10 days and a copy of the same be sent to the Commission as compliance.
