**ORDER:**

1. This order may be read with the reference of previous order dated 09.03.2022.

**Facts emerging during the hearing:**

2. From a perusal of the relevant case records, it is noted that the appellant is aggrieved with the fact that the desired information was not provided to him as third party's claim for the exemption of the information has been stated by the respondent PIO.
3. The respondent Sh. Purshotam Kumar stated that the information on the assets of concerned officials demanded in queries should not be disclosed since "the property returns submitted by the official are confidential documents and disclosure of this personal information has no relationship to the public activity or interest and hence denied under Section 8(1)(j)."

**Decision:**

4. The Commission, after hearing the submissions of both the parties and perusing the records, transpired that the Supreme Court has clearly ruled that even people who aspire to be public servants by getting elected have to declare their property details. "If people who aspire to be public servants must declare their property details it is only logical that the details of assets of those who are public servants must be considered to be disclosable. Hence the exemption under Section 8(1) (j) cannot be applied in the instant case."
