1. The RTI application is dated 21.06.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 04.08.2021 and the second appeal was filed in the Commission on 22.02.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 04.04.2022 through cisco webex. Shri Prabhjot Singh, appellant comes present to attend the hearing through cisco webex.
3. Shri Vijay Kumar, Environmental Engineer/PIO, Regional Office-2, PPCB, Ludhiana comes present to attend the hearing in person before the Bench. He states that a complaint was received from the appellant regarding burning of solid waste by Municipal Council, Doraha and that an officer of PPCB was deputed to inspect the site where the appellant was also called, but the appellant had not turned up there. Subsequently, the report was prepared and sent to the concerned Department for necessary action. The appellant has been given reply to this effect vide letter dated 24.09.2021.
4. On the asking of Bench, Shri Prabhjot Singh, appellant states that the information regarding burning of solid waste at dump site by M.C. Doraha has been received by him only three days back and he is not satisfied with the same.
