

It be further stated that nothing has been concealed therein and the information supplied is true and correct. Original affidavit along with a copy of the same be brought along and produced before the Bench.

7. With the aforesaid directions, the matter is adjourned. To come up for hearing on 31.08.2022 at 11:30 am in Commission's office at Chandigarh. Copies of the order be sent to the concerned parties.

<u>ORDER</u>

1. The RTI application is dated 28.09.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 28.10.2021 and the second appeal was filed in the Commission on 22.04.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 04.07.2022. Accordingly, the case has been heard today. Shri Charanjit Singh, appellant comes present to attend the hearing in person before the Bench.

3. Shri Rajesh Kumar, Addl. S.E., PSPCL,GGS Super Thermal Plant, Ropar, comes present in person before the Bench to attend the hearing on behalf of the PIO/respondent. He states that the RTI application has been transferred by Nodal Officer, RTI, PSPCL, Patiala to them as the information relates to GGSSTP Ropar and further states that the appellant has been supplied information vide letter dated 12.10.2021 and the appellant was also called to inspect the records on 28.10.2021, 17.11.2021 and 22.11.2021. He has, however, not come for inspection so far.

4. Shri Charanjit Singh, appellant refers to his submissions made vide e.mail dated 08.06.2022 and 27.06.2022 and states that he is not satisfied with the reply of PIO O/o GGSSTP, Ropar as he has not been provided the relevant document and further states that the information sought by him actually relates to the PIO/ Deputy Secretary, RTI, Patiala as he has raised issues regarding corruption and not to GGSSTP, Ropar and the RTI application has been wrongly transferred to them.

5. During deliberations, the appellant clearly brings out that the information sought relates to the PIO/Deputy Secretary, RTI Cell, PSPCL, Patiala and not PSPCL, Thermal Plant, Ropar. The issues raised by the appellant point to corruption of a high magnitude and pertains to Head Office of PSPCL, Patiala. Since it is a case dealing with corruption, the PIO/ Deputy Secretary, RTI, PSPCL, Patiala is directed to supply information to the appellant point wise on priority. The PIOs concerned are also directed to come present in person before the Bench on the next hearing.

With the aforesaid directions, the matter is adjourned. To come up for hearing on

<u>ORDER</u>
