That the appellant through RTI application dated 30.04.2019 sought information regarding copy of application form/request dated 25.08.2015 for electric connection No.A11SA441492M alongwith copy of bills issued and other information from the office of Addl. SE (Operational), PSPCL Division Ajnala. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 20.05.2019 which took no decision on the appeal.

That after filing first appeal, the PIO sent reply to the appellant vide letter dated 27.06.2019. On being not satisfied with the information, the appellant filed 2<sup>nd</sup> appeal in the Commission on 21.08.2019.

That the case came up for hearing on 30.12.2019. The representative appeared on behalf of the appellant informed that the PIO has not provided the complete information. The respondent was absent. The PIO was directed to relook at the RTI application and provide the complete information to the appellant within 10 days. The PIO was further directed to provide the information within 10 days of the receipt of order and send a compliance report to the Commission.

That on the next date of hearing which was held on **17.03.2020**, the appellant claims that the PIO has not provided the information. The respondent is absent on  $2^{nd}$  consecutive hearing.

Having gone through the record, the Commission observed that there has been an enormous delay of eight months in providing the information. The PIO-Addl. SE(Operational), PSPCL Division Ajnala was issued a **show cause notice under Section 20 of the RTI Act 2005 for not supplying the information within the statutorily prescribed period of time. The PIO was directed to file reply to the show cause notice on an affidavit.** If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such persons of the show cause and direct them to appear before the Commission along with the written replies.

The PIO was again directed to provide the complete information within 10 days of the receipt of this order.

That the case has come up for hearing today through video conference facility available in the office of Deputy Commissioner, Amirtsar. The appellant claims that the PIO has not provided the information.

That the PIO-Additional SE (Operational) PSPCL, Division Ajnalais absent on 3<sup>rd</sup> consecutive hearing nor has filed reply to the show cause notice.

Keeping the above-mentioned facts of the case, it is clear that the PIO-Additional SE (Operational) PSPCL, Division Ajnala is flouting the spirit of the RTI Act continuously. The PIO has not only shown utter disregard for the Commission's repeated orders to provide the information but has shown willful stubbornness in not replying to the Show Cause and not appearing before the commission despite various orders of the Commission.

To secure an erring PIO's presence before the commission the Information Commissionis empowered to issue warrants to Under Section 18(3) of the RTI Act. A bailable Warrant of the PIO-Additional SE (Operational) PSPCL, Division Ajnala is hereby issued through Senior Superintendent of Police, Amritsar for his presence before the Commission on**15.09.2020**.

To come up for further hearing on **15.09.2020 at 01.30 PM** through video conference facility available in the office of Deputy Commissioner, Amritsar. The PIO to **appear at Chandigarh.**
