He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.2500/- (Rupees Twenty Five hundred Only)** is awarded to the Appellant as compensation. I order accordingly.
