1. This order may be read with reference to the order dated 29.08.2022 passed by this Bench on the previous hearing.

The Drawing & Disbursing Officer concerned is directed to deduct the amount of penalty of Rs.5,000/- from the salary of the PIO and deposit the same in State Treasury in the following Head of Account and to report its compliance to the Commission before the next hearing:-

**- 0070-Other Administrative Services – 60-Other Services-**

**-0800-Other Receipts- 86-Fee under the RTI Act, 2005.**

5. The PIO is also directed to supply requisite information to the appellant and file reply to the Show Cause Notice as also to produce evidence for having deposited the penalty in the State Treasury, before the next date of hearing. The PIO is further directed to ensure to come present before the Bench in person on the next date of hearing, failing which the Bench will be constrained to issue bailable warrant to the PIO to ensure his presence before the Bench on the next hearing.

6. The Bench observes that a letter from the FAA-cum-A.D.C. Urban Development, Jalandhar is available in the case file wherein it has been stated that the post of Regional Deputy Director, Local Government has been abolished and now, the post of Additional Deputy Commissioner, Urban Development in each district has been created and the Municipal Council, Haryana comes within the jurisdiction of the Additional Deputy Commissioner, Urban Development, Hoshiarpur.

5. The Bench observes that show cause notice was issued to the PIO and on 24.11.2021, and penalty of Rs.5000/- was imposed. However, the PIO has neither filed reply to the show cause notice nor he has produced any evidence for having deposited the amount of penalty in the State Treasury.
