2. Sh. Ravinder Singh, Clerk handed over the copy of information to the appellant during the hearing.
3. Sh. Pardeep Pareeja the appellant states and presented various facts before the Commission, that despite of various reminders the respondent PIO, he/she did not bother to provide the requisite information on time, due to which he had lost lot of determinants for getting information. Therefore, he requested the Commission for compensation be awarded to him and penalty be imposed on respondent PIO.
4. After both the parties and going through the documents on record, it is also found that the RTI application is in question form, still the respondent has provided the available information to the appellant as mentioned above. The respondent PIO is also directed to submit copy of said cheque or demand draft of compensation once paid to the Commission.
