Parmod Kumar, DEO states that RTA, Patiala has given the reply vide letter no. 987 dated 23.03.2018. A copy of the same has been taken on record.

The Appellant, Sh. Manjinder Singh states that he is satisfied with information relating to the point no. 3 and he is not satisfied with the information relating to point no. 1 and 2.

After discussing with both the parties and going through the case file, it is observed that information which has been supplied to the Appellant is not presented as per the requirement of the Appellant. Commission takes a serious of this casual approach of the Respondent/PIO.

In view of the above, PIO O/o, Secretary, Regional Transport Authority, Patiala will **Show Cause** under Section 20 (1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI Appellant and why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

In addition, the PIO is also hereby given an opportunity under Section 20(1) provision, thereto, for a personal hearing to clear the facts of this case and to appear before the Commission with the sought for information, before imposition of such penalty on the next date of hearing.
